

**AGREEMENT**  
**(TO BE EXECUTED AT THE TIME OF ADMISSION)**

1. This Agreement is between:  
Shri/Smt. \_\_\_\_\_ Father/Mother/Guardian on the one part, and the principal, on behalf of the board of members of New Tehri International School Painula (New Tehri) on the other.  
Now, it is hereby agreed that my Son/Daughter/Ward \_\_\_\_\_ has been admitted as a student in Std. \_\_\_\_\_ at New Tehri International School.
  2. I shall see that my Son/Daughter/Ward is punctual in leaving the school and arriving on time at the end of a long or short holiday
  3. I shall pay the fees on time. In case of one month delay from due date I will pay fine.
  4. That I shall observe all the rules and regulations prescribed by New Tehri International School.
  5. That the placing of my Son/Daughter/Ward after a test, if necessary, into a class suitable to his/her age and attainments as a result of the test shall be at the sole discretion of the Principal.
  6. That the Principal can, at any time, in the interest of the school remove my Son/Daughter/Ward if he has failed to accept the norms and discipline of the school..
  7. That I accept the condition that in the event of my Son/Daughter/Ward having to leave the school as per 7 above or for any other reason whatsoever, I shall not claim my refund of money and dues paid to the school for the term except the security money and any money left on account from the impress of the term concerned.
  8. That withdrawal of my Son/Daughter/Ward is only permitted at the end of the term.
  9. That the STATUS of my Son/Daughter/Ward from day scholar to boarder and vice versa cannot be changed during the term.
  10. That one month's notice ending on the last day of term (May and December) is required for Boarder and Day scholars one month's notice of withdrawal to take effect from the 1st of March.
  11. That fee once paid is NOT REFUNDABLE on withdrawal or change of status during the term. Only the security deposit and amount left over from the imprest will be refundable as per the rules.
  12. That no transfer the Principal nor the Board of members of New Tehri International School individually or severally will be held responsible for any sickness, infection or injury sustained by my Son/Daughter/Ward while taking part in studies, sports and extracurricular and other forms of activities of the school within or outside the school premises or leaves the school premises without the written permission of the school authority and further he shall be willing in such circumstances to pay all the expenses incurred by the school in the treatment of such injuries without questions.
  13. And that if there is any dispute, as to the effect or meaning of these presents or in any way touching or arising out of these presents the same shall be referred to the soul arbitration of the general secretary of Christo Indian Educational Society New Tehri, whose decision shall be final.
  14. I shall ensure my ward appears for all examinations conducted by the school, including Class Tests, Unit Tests, Formative Assessments, Summative Assessments, Pre-boards, and especially board examinations. I acknowledge that in case of absence during an examination, no re-examination will be conducted under any circumstances.
  15. I understand that a minimum of 75% attendance is mandatory for my ward's promotion to the next higher class. In case of absence for more than three consecutive days, I agree to submit a valid medical certificate upon return. If my ward is absent without prior leave, I accept the fine imposed by the school.
  16. I agree that my ward will bring a personal vehicle to school only during examinations and that too with a signed application from us (parents/guardians) at least one week in advance. The application must be accompanied by a photocopy of the driving license. I accept that if the vehicle is seized due to the absence of prior approval, I will come to the school to retrieve the keys and pay the prescribed fine.
  17. Prohibited Items: Cameras, mobile phones, electronic gadgets, magazines, tattoos, pictures, sharp instruments, and blades are strictly not allowed inside the school premises. Any violation will result in immediate confiscation of such items. Mobile phones, smart watches, and other electronic gadgets, if confiscated, will be returned only after one week, and that too only to the parents, upon payment of a fine and submission of a written apology from the student.
  18. I accept that if my ward remains absent during national holidays or important school events, the school has the right to impose a fine, which I will duly pay.
  19. I agree to pay school transport fees for 11 months. Once the transportation facility is availed, it cannot be canceled later during the academic session.
